4 First Aid Measures

Inhalation:

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if breathing problems develop.

Skin Contact:

In case of skin contact, immediately remove contaminated clothing and wash skin and hair with running water. Seek medical attention if symptoms occur.

Eye Contact:

In case of eye contact, hold eyelids open and rinse with water for at least 15 minutes. Seek medical attention if symptoms occur.

Ingestion:

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

For small spills: If local regulations permit, mop up with plenty of water and run to waste, diluting greatly with running water. Otherwise absorb spill with inert absorbent material and transfer to a suitable container for disposal.

For large spills: absorb spill with sand, earth or other absorbent material. Transfer to a suitable container for disposal.

7 Handling and Storage

Precautions for Safe Handling:

Reacts violently with acids.

May be corrosive to metals and wood.

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Use only outdoors or in a well-ventilated area.

Take precautionary measures against static discharge. Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area. Keep container tightly closed when not in use. Only store in original container. Protect containers from physical damage. Protect from direct sunlight and moisture. Keep away from acids, oxidising agents, ammonium compounds, wood, organic halides, nitro compounds and active metals such as aluminium, tin or zinc.
