Eye Contact:

In case of eye contact, rinse with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing for at least 15 minutes. Seek immediate medical attention.

Ingestion:

If swallowed, do not induce vomiting. Immediately rinse mouth with water. Never give anything by mouth to an unconscious person. Seek medical attention.

Symptoms Caused by Exposure:

Inhalation: May cause respiratory irritation. Skin Contact: Causes severe skin burns. Eye Contact: Causes serious eye damage.

Ingestion: May cause gastrointestinal irritation, nausea, diarrhoea and vomiting.

6 Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear approved respiratory protection, chemical resistant gloves, protective clothing and safety boots. Evacuate all non-essential personnel from affected area. Do not breathe vapours. Ensure adequate ventilation.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. If not available, try to create a dike to stop meaterial spreading. Collect the spilled material and place into a suitable container for disposal. Clean spill area with water and detergent.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Use only outdoors or in a well-ventilated area.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area. Keep container tightly closed when not in use. Some liquid preparations settle or separate on standing and may require stirring before use. Protect from extreme temperatures. Keep away from oxidising agents.

8 Exposure Controls and Personal Protection

Exposure Standards:
