## 4. FIRST AID MEASURES

**Swallowed** If swallowed, DO NOT induce vomiting or give anything by mouth. Seek immediate medical attention. Do not leave victim unattended. Vomiting may occur spontaneously. To prevent aspiration of swallowed product, lay victim on side with head lower than waist. If vomiting occurs and victim is conscious, give water to further dilute the chemical.  
**Eye** Immediately flush eyes thoroughly with plenty of water for at least 15 minutes, ensuring eye lids are held open. If irritation persists, transport to hospital or doctor.  
**Skin** In case of contact, immediately wash with plenty of soap and water.  
**Inhaled** Respiratory irritation or distress should not normally occur using this product. If this condition occurs, remove the victim to fresh air. Seek medical attention if respiratory irritation or distress continues. If breathing is difficult, give oxygen. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device as a bag or mask.

<b>Engineering Controls</b>	Where engineering controls are indicated by use conditions or a potential for excessive exposure exists, the following exposure techniques may be used to effectively minimize employee exposures.
<b>Eye Protection</b>	When engaged in activities where ingredients could contact the eye, wear safety glasses with shields or goggles. In extremely dusty environments and unpredictable environments, wear unvented or indirectly vented goggles to avoid eye irritation or injury.
