#### 5. FIRE FIGHTING MEASURES

#### **6. ACCIDENTAL RELEASE MEASURES**

#### Personal Precautions, Protective Equipment and Emergency Procedures:

Wear Safe Work Australia approved self-contained breathing apparatus and full protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe vapours. Ensure adequate ventilation.

#### **Environmental Precautions:**

In the event of a major spill, prevent spillage from entering drains or water courses.

#### Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so. Slippery when spilled.

For small spills: If local regulations permit, mop up with plenty of water and run to waste, diluting greatly with running water. Otherwise absorb spill with inert absorbent material and transfer to a suitable container and arrange removal by a disposals company.

For large spills: absorb spill with sand, earth or other absorbent material. Transfer both solids and liquids to a suitable container for disposal. Treat residues as for small spillages.

# 7. HANDLING AND STORAGE

#### **Precautions for Safe Handling:**

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Use only outdoors or in a well-ventilated area.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

#### Conditions for Safe Storage:

Store in a cool, dry and well ventilated area, out of reach of children. Keep container tightly closed when not in use. Keep away from oxidising agents, casutic alkalis and strong acids. Large quantities should be stored in a bunded area.

#### **Acute Health Effects**

**Inhalation:** Inhalation is an unlikely route of exposure due to the non-volatility of ingredients.

**Skin:** May cause mild irritation. Will have a degreasing effect on skin which may cause further irritation.

#### Ingestion:
